AFFIDAVIT

- I, Sushil Thapar, Councillor of the City of Quesnel, of 806 Avison Avenue, Quesnel, British Columbia, AFFIRM THAT:
 - I am a Councillor of the City of Quesnel (the "City"), and as such have personal
 knowledge of the facts and matters hereinafter deposed to, and swear that all such
 matters are true.
 - 2. I was elected to Quesnel City Council in 2002.
 - 3. I have read the Petition and the Response in this matter.
 - I agree with Part 4, paragraph #2 of the Response. Motion was made to determine this
 position of council.
 - I attended the meeting of April 16, 2012, referred to in the Petition; I never voted on any severance payout.
 - 6. No severance payment for John Steyck was discussed at the April 16th meeting.
 - There were a number of in-camera meetings held prior to and after the above mentioned meeting by the Executive Committee without notice. No notes or minutes were provided by the Executive Committee.
 - Around this time, Respondent Mary Sjostrom asked me to sign a letter on City letterhead agreeing to keep everything regarding the John Stecyk matter confidential. I refused to sign the letter, but I believe the other councillors signed it.

- 9. John Steyck's termination came as a result of an April 9th regular meeting. There was cause for termination.
- 10. During negotiations of John Steyck's contract Jack Marsh, the acting City Manager, allowed the assistant to the Human Resources Manager to remove the Mitigation Clause in the contract that the Human Resources Manager had prepared and was expecting Stecyk to sign. It was removed at the request of John Steyck. As a councillor, I was not notified beforehand.
- 11. I read both evaluations of John Steyck's employment prepared by Jim Craven prior to the end of John Steyck's 6 month probation period. The second evaluation omitted unfavourable reviews and kept favourable reviews. The people who provided favourable reviews, Ken Coombs and Matt Wood, were both promoted following their reviews.
